Cancellations made after May 1 and before June 1, are subject to a 50% cancellation fee. No refunds will be given for Booths cancelled after June 1<sup>st</sup>. **Application and Fees – Due June 1<sup>st</sup>.** If you are not accepted, your fee will be returned to you by July 21<sup>st</sup>. Notice of acceptance will be made by June 20, 2009. **No refunds will be issued after vendor has been notified of acceptance.**

**Additional Fees:** An additional fee of 10% of your gross sales (or \$10 if an exhibition booth) will be due at the end of the day payable to the City of Seattle. This operates on the Honor system and a Festival Representative will come to each booth at the end of the day to collect these fees.

**Booths:** Your booth must be designed to withstand wind and inclement weather with your display adjustable for surface grade. You are responsible for supplying your own canopy, table, chairs, carpet, etc. Power is not included in your booth fee, but can be provided to a limited number of vendors.

**Security:** The event maintains good security; however, we accept no responsibility for loss or damage.

**Insurance:** Rides and Attractions must provide a Certificate of Insurance naming the Seattle Seafair Pirates and the City of Seattle as additionally insured. The certificate must be submitted before June 1, 2009.
